REPORT OF THE SECRETARY GENERAL OF THE OSCE PARLIAMENTARY ASSEMBLY TO THE STANDING COMMITTEE

Report to the Standing Committee 2017 Winter Meeting 23 February 2017

OSCE PA Secretary General Roberto Montella

The Autumn of 2016 proved to be an exceptionally busy time for our Assembly and the International Secretariat, due both to external and internal factors. In the months following my last report to the Standing Committee at our meeting in Skopje, we deployed election observation missions on seven occasions and supported President Muttonen's busy schedule of activities. The Secretariat work on consolidating our structure has continued, with a particular focus on administrative and financial matters.

It has been my honour to lead the Secretariat for a full year now, and it was a particular pleasure to do so during our 25th anniversary year. We marked this occasion in appropriate fashion, together with representatives of OSCE participating States in October, and I want to thank President Muttonen for her contribution to this event. I also extend the Secretariat's thanks particularly to those countries that hosted Assembly meetings in such a warm manner during these recent months in Copenhagen, Tbilisi, and Skopje. Their willingness to host our meetings is a major contribution to the Assembly. In this regard, I want to sincerely thank Denmark, which above and beyond their regular budget contribution, hosts our headquarters in the centre of Copenhagen. I also want to thank the Austrian Government for their continued support to our Liaison Office in Vienna, and the Italian Government for supporting the secondment of two staff members of our Secretariat.

Strengthening of the International Secretariat (internal reform)

As I have previously reported, one of my key priorities upon taking up my duties was to work on a general strengthening and consolidation of the International Secretariat. This has proved to be a complex and indeed challenging undertaking which first and foremost derived from the need to adapt the work of the Secretariat to evolving needs and changing circumstances. In pursuing this overarching objective and in line with your expectations, I have prioritized the principles of efficiency, effectiveness, transparency and accountability as an integral part of the reform process.

In the first six months of my mandate as your Secretary General, I put in place effective and clear **Staff Rules and Regulations and a Code of Conduct** that govern our work. In consultation with the President and the Treasurer, Deputy Secretary General Gustavo Pallares and I are now in the process of drafting **Financial Rules and Regulations** governing our internal financial management. We are studying and using the acquis of similar international organizations (OSCE, NATO PA, UN) while elaborating our own rules. The ultimate objective is to provide greater clarity of responsibility as well as enhanced accountability and transparency in budgetary matters of the Secretariat. It is my intention to seek the endorsement of the OSCE PA leadership for such a set of rules in the near future.

To complement these clearer financial rules and regulations that will govern our work, I expect that we will need to make a few **adjustments to the structure of our next budget**. We remain acutely aware of the need for increased financial and operational diligence as means to counteract a protracted general economic downturn. Some of the desired results of these reforms will take additional time, and for the time being, I would like to thank all Members of Parliament for the precious advice you have shared with me in this crucially important undertaking. My sincere thanks and deep gratitude

also go to all my colleagues at the Secretariat for their collective efforts and support during this process, which is in the best interest of our Organization. I consider the improvements being made as a collective success.

In order to better service the Assembly, we have continued to have staff participate in training mechanisms provided by the OSCE. These possibilities for members of our team to undertake training in areas relevant to their responsibilities is an important benefit deriving from our enhanced cooperation with the OSCE's executive structures in the past year. I also take this opportunity to thank **Secretary General Lamberto Zannier** and **Conflict Prevention Center Director Marcel Pesko** and their colleagues in the OSCE Secretariat for the open and pragmatic co-operation we have developed in this and other fields during the past year.

Finally, I offer a personal and institutional thanks to **Mr. Kurt Lerras**, who has been serving the OSCE PA faithfully for 24 years in various capacities, including most recently as Administrative Director. Mr. Lerras has decided to leave the permanent staff of the OSCE PA, but upon request of the management has agreed to continue working for the Secretariat in the coming year on a part-time consultancy basis.

Co-operation with Partners (external outreach)

Our efforts to strengthen co-operation with our traditional partners (including other OSCE Institutions, PACE, NATO PA, EU Parliament and the CIS IPA) has yielded results in several fields in recent months.

Our intensive participation in early January in the Annual Meeting of Heads of Missions and Institutions with the OSCE Chairmanship was a clear display of our close co-operation within the OSCE, as are our regular co-ordination meetings with OSCE senior officials and the daily interaction between the Vienna Liaison Office and the OSCE Secretariat.

In the field of election observation, thanks also to the wise and **constructive leadership of Director Michael Link**, we have further **enhanced our co-operation with ODIHR** by introducing an additional focus on the period after elections. Given the important role that legislative **follow-up** often plays in addressing challenges that may be identified, we have agreed with ODIHR that when possible and appropriate, the Special Co-ordinator, an OSCE PA senior official leading the short-term OSCE observer mission, will also participate in the presentation of ODIHR's Final Report. This typically takes place some 2-3 months following an election, and presents an excellent opportunity to encourage appropriate follow-up at the domestic level to recommendations that our observers may have. In recent months, Mr. Kent Harstedt and Mr. Ilkka Kanerva participated, respectively, in visits to Belarus and Russia to this end. We hope that similar visits can take place when feasible in the coming future.

In the field of elections, we've continued our usual good co-operation with our traditional parliamentary partners, and are planning to meet again at senior staff level, as we did the late Summer of 2016 north of Copenhagen. I also took the opportunity to participate in an 'implementation meeting' of the Declaration of Principles for International Election Observation, to examine opportunities that may arise from our adherence to this document.

The International Secretariat is also working closely with colleagues from the Inter-parliamentary Assembly of the CIS (CIS IPA) on a conference on combating terrorism, expected to take place in

St. Petersburg in March. We see this as the continuation of our traditional good co-operation with the CIS IPA, and look forward to a successful conference.

I also participated in a meeting of the Secretaries General of PABSEC countries, which served as an opportunity to solidify our relations, as well as to exchange views with colleagues from the Parliamentary Assembly of the Mediterranean, CIS IPA, PACE, TURK PA, and the Baltic Sea Parliamentary Conference among others.

Activities of the International Secretariat in support of Members

Our Secretariat team and I have taken special care to keep abreast of developments of relevance within the OSCE region and particularly regarding the vast array of activities and initiatives undertaken by the OSCE Secretariat, by the Executive Structures and by the other OSCE Institutions. I believe our efforts have enabled the OSCE PA International Secretariat to better provide analytical support and policy advice on issues of strategic importance to the OSCE and the Parliamentary Assembly. This has strengthened the Assembly's input and contributed to increased and more incisive public messaging by the PA in the best interest of the OSCE participating States and of the Organization. Together, we have contributed to elevating the profile of the PA within the OSCE and beyond. We plan to continue to do our utmost to best support and advise on Assembly policies.

We recently organized the **deployment of election observation missions on seven different occasions** within a two-month period. This required calling on almost all of our small team of staff to support the election observation teams. We supported teams of observers in **Georgia** (8 October and again for the second round on 30 October) led by Ignacio Sanchez Amor and Guglielmo Picchi; in **Montenegro** (16 October) led by Margareta Cederfelt and Azay Guliyev; in **Moldova** (30 October and again for the second round on 13 November) led by Arta Dade and Geir Joergen Bekkevold; in the **United States of America** (8 November) led by President Christine Muttonen and Makis Voridis; and finally in **the former Yugoslav Republic of Macedonia** (11 December) led by Roberto Battelli and Azay Guliyev. Further details on all our 2016 election observation activities can be found in the attached '2016 Election Observation Overview.'

We have provided appropriate support to **President Muttonen**, who has been very active in this first part of her Presidency. The President has paid **official visits to London and to Moscow**, held several meetings with senior **UN** officials in **New York** and also took the opportunity to address a Summit of Women Speakers of Parliament, organized by the Inter-parliamentary Union. The President also held several substantive bilateral meetings with Foreign Ministers on the sidelines of the Hamburg Ministerial Council meeting, in addition to presiding over our Bureau meeting on that occasion, and participating in the opening of the OSCE Chairmanship in Vienna.

The Secretariat has also continued to support activity by other Assembly bodies. Deputy Secretary General Semyon Dzakhaev has overseen our support to the **Sub-Committee on Rules of Procedure and Working Practices led by Lord Peter Bowness** which has produced **amendments** that have been proposed to the Standing Committee for the Vienna Winter Meeting. I would also like to highlight the continued active work of Programme Officer Farimah Daftary in supporting our **Ad Hoc Committee on Migration**, whose Members, under the leadership of **Chairman Filippo Lombardi**, have maintained an ambitious approach and held useful and substantive policy-focused meetings in Brussels and Geneva last month.

In Copenhagen and in our Liaison Office in Vienna under the leadership of Ambassador Andreas Nothelle, we continue to welcome visits by national delegations, and since Skopje we have received visits by parliamentarians from Austria, Finland, France, Portugal and Sweden.

Upcoming Events

Continuing preparations for our statutory meetings, our Secretariat team has paid two visits **to Minsk in preparation for our Annual Session** this coming summer. We very much hope that it will be a productive and successful event. Looking ahead further, the Secretariat has also visited **Andorra** to work with colleagues there in preparation for our **2017 Autumn Meeting**, and visits will also take place soon to **Berlin in preparation for the 2018 Annual Session** and to **Bishkek** in preparation for the 2018 Autumn Meeting.

We are also actively preparing to deploy an election observation mission for the 2 April **elections in Armenia**; in early December last year Programme Officer Loic Poulain travelled to Yerevan as a part of ODIHR's Needs Assessment Mission for the elections. In addition, we have started planning for a mission to observe the parliamentary elections in **Albania**, scheduled for the 18th of June.

Preparations are also ongoing for another Leinsweiler retreat in early May, and we appreciate the German government's decision to once again fully finance this project.

I would like to conclude by **thanking** all the Members of the Bureau, the Standing Committee and the numerous **Members of Delegations** who have personally approached me with advice, suggestions, and proposals during the past year. I value and deeply appreciate the personal interaction and the informal and friendly communication I have with Members. I would also like to express my deep gratitude for the commitment and the professional delivery of all the members of the **staff**, including the valuable contribution of the **Research Fellows** both in Copenhagen and in the Vienna Liaison Office. As I have underlined in the past, the International Secretariat works as a team and it is with this renewed team spirit that we look forward to continuing serving the Members of the Assembly.
