#### **SPOTLIGHT: Presiding the UN Coordination Mechanism**

From June 2022 to December 2024, the OSCE PA held the inaugeral presidency over the global Coordination Mechanism of Parliamentary Assemblies on Counter-Terrorism. Under the OSCE PA's leadership and in co-operation with the UN, the Mechanism held four official meetings and four Parliamentary Policy Dialogues in Doha, Vienna, Istanbul, and Rome, and has grown to now include 17 Assemblies worldwide, reflecting a shared commitment to strengthening the parliamentary role in counter-terrorism.

1	Areas of
21	Focus

- Promote the successful prosecution, rehabilitation, and reintegration of FTFs and their families, including women and children.
- Strengthen border security and information sharing through sound Advance Passenger Information (API), Passenger Name Records (PNR) and biometric data management systems, in accordance with UNSCR 2396.
- Foster prevention efforts and promote sensible guidance to counter on-line radicalization to violent extremism with a special focus on youth.
- Support victims of terrorism and strengthen the role of victims' associations through advocacy and awareness-raising.
- Explore the intersection of terrorism with other challenges, such as those posed by organized crime, artificial intelligence, hybrid threats, migration and climate change.

#### **Key Achievements**



**Strengthened the engagement of parliamentarians, assessed new trends and shared key lessons learned** through dozens of expert meetings (20), international and regional conferences (20) and field visits to OSCE participating States (10).

### Developed innovative policy guidance to boost legislative convergence in key areas:

- <u>Resolution on Artificial Intelligence and the Fight</u> <u>against Terrorism (2024 Bucharest Resolution)</u>
- <u>The Wagner Group's Terroristic Nature and</u> <u>Actions (2023 Vancouver Resolution)</u>,
- <u>Victims of Terrorism (2022 Birmingham</u> <u>Resolution),</u>
- <u>Addressing the Threats Stemming From the</u> <u>Return & Relocation of FTFs (2019 Luxembourg</u> <u>Resolution)</u>,
- <u>Preventing and Countering Terrorism and</u> <u>Violent Extremism and Radicalization that Lead</u> <u>to Terrorism (2018 Berlin Resolution)</u>.

**Promoted the implementation of relevant international obligations**, such as those on <u>border security and information sharing stemming</u> <u>from UNSCR 2396 (2019)</u>, through parliamentary oversight initiatives, consistent public messaging and contribution to numerous publications, including the <u>Parliamentary Handbook on</u> <u>Promoting the Implementation of UN Security</u> <u>Council 1373 (2001) on Countering Terrorism</u> (2024)

**Boosted international co-operation** through a network of partnerships, including with the OSCE, the United Nations and various interparliamentary assemblies. Notably. the OSCE PA presided over the first **Co-ordination Mechanism of Parliamentary Assemblies on Counter-Terrorism,** established under UN aegis, from June 2022 to December 2024.

**Encouraged OSCE governments to uphold inclusive and human rights-based responses** to counter terrorism & disinformation, especially during the **COVID-19 emergency** (2020-2022).
