### Serve as a focal point for the OSCE PA's work in the field of migration

in all three dimensions of the OSCE: political and security affairs; economic and environmental issues; and human rights and humanitarian questions; and report back to the President and the Standing Committee;

**Develop policy recommendations** aimed at enhancing OSCE work in the field of migration and at improving the treatment of, and prospects for, migrants in OSCE countries;

**Promote discussion** within the Assembly on issues related to migration and promote parliamentary exchanges of best practice in these fields;

Work closely with the OSCE Secretariat and Institutions as well as with relevant outside actors on issues related to migration to promote understanding among the members of the Assembly.











- The Committee regularly undertakes field missions to countries impacted by irregular migratory flows. Past field visits include: France (2016); Italy (2016, 2017, 2024); Greece (2017, 2022); Türkiye (2017, 2024); Belgium (2018, 2019); Serbia (2018); Sweden (2018); and Denmark (2018).
- Following the onset of the **Covid-19 pandemic**, the Committee initiated a series of online exchanges on topics such as the situation in Lesbos (Greece) and the Lipa camp (Bosnia and Herzegovina) and the impact of Covid-related restrictions on migrant communities.
- In 2022-2023, the Committee focused on the **Ukraine Refugee Crisis**. It carried out two focused visits to Czechia (December 2022) and Moldova (March 2023) with the aim to share 'best practice' and identify areas where further support is needed.
- In 2024, the focus shifted back to the **Mediterranean**, with two field visits (Lampedusa March 2024, and Türkiye May 2024) in response to the uptick in irregular migration. Furthermore, for the first time, the Committee visited OSCE Mediterranean Partner for Co-operation Morocco in September 2024.
- The Committee also regularly engages in policy dialogue with key stakeholders at the European and international levels.

- Field missions to frontline, transit and destination countries with the objective to identify examples of 'best practice' and areas for further improvement.
- Highlighting the specific challenges in relation to persons in vulnerable categories, in particular women, unaccompanied and separated minors, and victims of trafficking in human beings and gender-based violence.
- > Formulation of resolutions containing detailed recommendations on:
- "Strengthening Safe and Regular Pathways for Migration" (2024);
- "Effective Migration Governance based on Promoting Inclusive Societies and Dignified Returns" (2019);
- "Minors on the Move: The Role of the OSCE and the OSCE Parliamentary Assembly in Building an Effective Protection Framework" (2018);
- "Ensuring a Coherent, Shared and Responsible Governance of Migration and Refugee Flows" (2017).
- Enhanced dialogue with the OSCE, other parliamentary assemblies, the European Commission, as well as relevant international organizations and NGOs on enhancing migration governance.

### History

The OSCE PA has increasingly devoted attention to migration issues since 2013, following the Syrian refugee crisis. As the crisis deepened in 2015/2016, PA delegations visited a number of refugee camps in Türkiye, Italy and South East Europe.

The Committee has been chaired since September 2023 by Vice-President Dr. Daniela De Ridder (Germany). Previous Chairs of the Committee: Filippo Lombardi (Switzerland), Nahima Lanjri (Belgium), Margareta Cederfelt (Sweden), Kristian Vigenin (Bulgaria) and Rt. Hon. Mark Pritchard (United Kingdom).
