Assembly prepares for Annual Session



On 29 and 30 May three members of the International Secretariat paid a final preparatory visit to Brussels for the 15th Annual Session to be held in the Belgian capital from 3 to 7 July. Deputy Secretary General Vitaly Evseyev, General Services Officer Kurt Lerras and Presidential Advisor Gustavo Pallarés met with the staff of the Belgian Federal Parliament to review and finalise all aspects of the Annual Session including the programme and organizational modalities. Under a unique arrangement with the Belgian Federal Parliament, the Annual Session will be held on the premises of the European Parliament. The Secretariat team visited the the European Parliament, which will provide excellent conditions for the Session.

The Belgian hosts are organizing an interesting and enjoyable social programme, including an excursion and an opening reception in the presence of his Majesty the King Albert II.
