OSCE PA Secretaries of Delegation briefed on modalities for Remote Annual Session



A n online meeting was held Tuesday to brief OSCE PA Secretaries of Delegation on the modalities and technical aspects of the 29th Annual Session, which will take place during the first week of July for the first time in an online format. Due to the realities of the COVID-19 pandemic, an in-person meeting in Bucharest had to be cancelled, it was explained, and the OSCE PA Bureau decided on 19 April to hold a Remote Annual Session, which will consist of meetings of the Standing Committee, the three general committees, and one plenary session.

The agenda of this virtual session will be limited to reports, topical debates, election of officers, administrative issues, and questions of urgency. Reports prepared by the committee rapporteurs will be presented at the Annual Session on matters related to OSCE's three dimensions of security, and urgency items, it was explained, must be pertinent to the OSCE process and relate to an event which has taken place or come to public knowledge less than 24 days before the Annual Session. The Standing Committee, which will meet on 5 July, must agree by the principle of consensus-minus-one to place the urgency items on the agenda of the plenary, which will vote on them on 6 July.

Opened by OSCE PA Secretary General Roberto Montella, Tuesday's meeting covered issues such as practical and procedural arrangements, timeline and deadlines, and the voting procedures for elections of Assembly and general committee officers. 7 June is the registration deadline for eligible voters, Secretaries of Delegation were told, as well as for presenting candidatures. On 10 June, a Bureau meeting will be held to validate candidatures, for rapporteurs to present reports, and to take a decision on approval of the Remote Session agendas.

A follow-up meeting will be held on 11 May for a more practical training session to acquaint staff with the online registration system.

OSCE PA Special Representative on Arctic Issues meets with Sami Council

Special Representative on Arctic Issues Torill Eidsheim (Norway) met on Monday with Gunn-Britt Retter, Head of the Environmental and Arctic Unit of the Sami Council, the largest organization bringing together representatives of Sami people in five different countries. The meeting focused on the impact of the climate crisis on Arctic indigenous communities and on other challenges faced by the Sami in the High North.

Discussions also touched upon the dynamics of political representation of Sami people in national parliaments as well as their engagement in international bodies. Special



Representative Eidsheim reiterated, in particular, the intention to include views and perspectives of Arctic indigenous communities in her work in the PA.
