OSCE PA Secretary General Roberto Montella highlighted the central role of parliamentarians in meeting these challenges and expressed his view that international co-operation is essential to find solutions to common challenges.

In the discussion, points were raised about trust in institutions being important to ensure access to health care, particularly for vulnerable groups like migrants and refugees. This is particularly true, it was stressed, because people on the move are in more need than others to have good access to health care. Gender aspects of health care access were also emphasized as important.

## OSCE PA Migration Committee meeting focuses on challenges facing Greece

embers of the OSCE Parliamentary Assembly's Ad Hoc Committee on Migration met online Monday with Sofia Voultepsi, Deputy Minister of Migration and Asylum in Charge of Integration, to hear about Greece's COVID-19 mitigation measures and the roll-out of vaccination programmes for the asylum-seeking population of the Aegean Islands. Chaired by OSCE PA Vice-President Margareta Cederfelt

(Sweden), the meeting also included participation by Dimitrios Markopoulos (Greece), Member of the Ad Hoc Committee on Migration, who shared additional information about vaccination efforts, including the extensive education programme to convince refugees to take part in the programme. Cederfelt emphasized that it is not an easy task for Greece and urged shared responsibility among the European Union member states.

### Second Committee Rapporteur speaks about regional development in Greece

SCE PA Second Committee Rapporteur Elona Gjebrea Hoxha spoke about the OSCE's work in the economic and environmental dimension at the Regional Growth Conference in Patras, Greece, which took place 3-5 June. Speaking at the session on "Regional Governance and Regional Growth," Hoxha focused her remarks on the inequalities the affect the wealth and well-being of society, highlighting the Assembly's work on these issues and stressing that multilateral co-operation is essential to create a broad approach to regional development.

n 3 June, OSCE PA Vice-President and Special Representative on Mediterranean Affairs, Pascal Allizard (France) held meetings in Vienna with representatives of the OSCE executive structures and the OSCE PA Vienna Office, including OSCE Secretary General Helga Schmid, the French Permanent Representative, Amb. Christine Fages, and Amb. Marcin Czapliński of Poland, which is currently chairing the OSCE Mediterranean Partnership of Co-operation Group. The delegation, which included Fabrice Hugot from the French Parliament and Fabien Patry from the French mission in Vienna, was accompanied by OSCE PA Special Representative Andreas Nothelle.

Allizard also received a thorough briefing by Ambassadors Zannier and Pančeski on the state of affairs in the Organization, on the Assembly's Helsinki +50 initiative including on upcoming activities as well as on recent and upcoming election observation missions. The VP stressed the importance of regular communication and information sharing with national parliaments on challenges affecting the international security agenda.
