President Cederfelt visits the United States for meetings and speaking engagements

OSCE PA President Margareta Cederfelt (Sweden) has been on a visit to the United States, meeting last week in Washington with Members of the US Delegation to the OSCE PA and participating in a number of events. On 16 December, Cederfelt met with OSCE PA First Committee Chair Richard Hudson, and on 14 December, she met with Vice-President Roger Wicker and Special Representative on Anti-Semitism, Racism and Intolerance Ben Cardin, as well as Member of the US Delegation Steve Cohen, for discussions that focused on Euro-Atlantic co-operation and the increasing threats to human rights and territorial integrity in the OSCE area.

Discussions touched on Afghanistan, the human rights situation in Belarus, the Russian military build-up on the border with Ukraine, and the general state of the European security order. Cederfelt expressed appreciation for the dedicated engagement of the US Delegation to the OSCE PA and the US Helsinki Commission, including Special Representative Cardin's work on promoting tolerance and non-discrimination in the OSCE area. The President also met with Helsinki Commission staff and discussed plans for OSCE PA activities in 2022, with a focus on the upcoming Winter Meeting.



While in Washington Cederfelt also hosted a roundtable at the Atlantic Council, focused on the issue of European challenges and how the crisis in and around Ukraine is a threat to the European security order. On 17 December, the President spoke at a Council on Foreign Relations event entitled "The OSCE and Human Rights in Europe Today." The discussion focused on challenges to democracy and human rights and the role of the OSCE in addressing them, including the important contributions of the Parliamentary Assembly. Cederfelt emphasized continued dialogue and co-operation within the forum of OSCE in order to secure a more democratic and safe future.

Taverna was appointed Special Representative on Elderly Issues in August 2021.

The OSCE PA will adapt accordingly to the requirements in place in the host countries to ensure full compliance with the preventative measures to safeguard our delegates. We appreciate your patience and your understanding in this regard.

It is thanks to all of you that the Parliamentary Assembly continues to expand its impact on the most pressing issues facing the OSCE region today, and to uphold our common values and the principles enshrined in the Helsinki Final Act of 1975. It is therefore with deep gratitude and respect that I would like to wish you and your dear ones a happy holiday. May 2022 bring you health, happiness, and success.
