## President Kauma addresses OSCE Chairpersonship's gender conference in Tetovo



Speaking Tuesday at the high-level opening session of the OSCE Chairpersonship's Gender Equality and Women's Empowerment Conference in Tetovo, OSCE PA President Pia Kauma (Finland) underlined that in times of crisis, vital topics such as gender equality must not be neglected. "I strongly believe that, while actively working with OSCE participating States and their parliaments, we ought to lead by example," President Kauma said.

In this regard, the President informed the conference participants that at its Annual Session in July, the OSCE PA amended its Rules of Procedure to ensure that gender equality is taken into account when appointing Chairs and Members to Ad Hoc Committees. The PA, she recalled, has long benefited from the work of its Special Representative on Gender Issues and has adopted numerous resolutions focusing on gender equality and women's empowerment, recognizing the excellent contributions by various OSCE offices on gender equality.



tella and Chief of Staff Andreas Baker, President Kauma has held a number of bilateral meetings on the margins of the conference in Tetovo. Meeting with OSCE Chair-in-Office Bujar Osmani, Kauma underscored the need for continued co-operation between OSCE parliamentarians and the OSCE governmental side, particularly in these times of unprecedented political challenges. She welcomed the attention paid by North Macedonia's Chairpersonship to the critical topics of gender equality and women's empowerment.

President Kauma also met with OSCE Secretary General Helga Schmid for discussions that focused on the state of the OSCE. The President noted that OSCE parliamentarians are concerned about the challenges facing the organization, stressing that this may be the most important time in its almost 50-year history, and urged stronger co-operation between the Assembly and all OSCE structures.

On Thursday, President Kauma will address the ambassadors of the 57 OSCE participating States at the Permanent Council meeting in Vienna.
